Are you working or planning to work in traffic management? In WA, you need to be accredited by Main Roads WA (MRWA).

COURSE OVERVIEW

The Basic Worksite Traffic Management (BWTM) and Traffic Controller (TC) accreditation is a Main Roads WA mandatory requirement for those installing signs and controlling traffic on WA roads. This nationally accredited course provides the skills and knowledge required to implement traffic management plans, install and maintain traffic management signs and devices at worksites and events, and conduct traffic control using a stop-slow bat.

Civil Train Western Australia is a Main Roads WA approved training provider.

COURSE OUTCOME

Upon successful completion of this course participants will be issued with the Main Roads WA accreditation and ID card, and a Statement of Attainment for the following nationally recognised units:

- RIIWS302E - Implement traffic management plans
- RIIWS205E - Control traffic with stop-slow bat
- RIICOM201E - Communicate in the workplace
- RIIWS201E - Work safely and follow WHS policies and procedures

ENTRY REQUIREMENTS

Participants will need to meet the following to qualify for the refresher course.

- Hold the WorkSafe Construction Safety Awareness Card (White or Blue card)
- Currently hold or previously held a drivers' licence (must provide evidence of this)
- Provide a Unique Student Identifier (USI)

Entrants will need a level of language and literacy skills to enable them to meet the requirements of the course. Civil Train recommends year 10 school completion or equivalent as a guide to the level required for short courses. The entrant must be able to use the English language at a level that is appropriate to:

- comply with written and verbal reporting requirements and procedures
- communicate clearly and concisely with others to receive and clarify work instructions
- communicate clearly and concisely with others to resolve coordination requirements prior to commencing and during work activities
- identify and select appropriate traffic guidance scheme and implement traffic management plans
- apply legislative requirements
- describe the effects of travel speed and vehicle mass on stopping distances
